

COMPANY NAME CHANGE.

GENERAL MOTORS - HOLDEN'S LTD. TO GENERAL MOTORS - HOLDEN'S PTY. LTD.

Research indicates that the above name change was instigated by Mr E. S. Hogland (General Manager, General Motors Overseas Operations) during his visit in mid 1957.

Profits were high and it was generally known that they were being transferred to the U.S. - balance sheets had to be published.

in house use of the new name commenced in about September 1957.

Official registration of the new name was not granted until May or June 1961 as indicated in the forms below - time did not permit the re-print of the 1961 form for its despatch to employees prior to the end of June.

This 3½ year delay (1958 to mid June 1961) was due to various problems, particularly the required acquisition from the owners of all previously issued preference shares. Subsequent publication of balance sheets was not required.
